#### Requirement of Radio Operators on Contract Basis (Advt. 04/2019)

### Walk- in-Interviews on 18.06.2019

The Shipping Corporation of India Ltd. Requires (Two) Radio Operators on Contract Basis for Technical & Offshore Services Division – Offshore Department for a period of Two (2) year, extendable if required by a period of Six (6) months.

# I. The Terms of contract will be as follows:

#### 1. CONTRACT TENURE

The contract shall be valid for Two (2) year from the date of engagement on contract which may be extended for six (6) months at the sole discretion of Corporation on the same terms and conditions. This is purely a temporary contract and shall not lead to permanent appointment.

#### 2. NUMBER OF REQUIREMENTS

There are a total of two (2) requirements

#### 3. QUALIFICATION

Candidate should be minimum 12<sup>th</sup> Standard passed and holding General Operator Certificate (GOC) to operate GMDSS equipment.

#### 4.<u>AGE</u>

The age of the applicant should not be more than 58 years as on 1<sup>st</sup> May 2019.

# 5.<u>EXPERIENCE</u>

Minimum One Year experience in handling MF/HF SSB and VHF sets. Candidate should have basic computer knowledge.

# 6.EMOLUMENTS

Consolidated emoluments of Rs.55,000/- (Rupees fifty five thousand only) per month. No other perks/benefits/allowances shall be applicable except conveyance for visiting to Dock or to any other offices. Income tax will be deducted at source as applicable.

# 7.<u>LEAVE</u>

(i) Thirty (30) days leave for contract tenure of one (1) year. For any absence over and above 30 days leave (excluding one day weekly rest), necessary deductions in your consolidated emoluments would be made on prorate basis.

(ii) Weekly one day rest is applicable.

#### 8. WORK TIMINGS

Each selected Radio Operator will be generally required to work 44 hours in a week except in case of an Emergency. Any extra work will be done will be offset as additional leave apart from leave mentioned in point no.7.

# 9.<u>Termination:</u>

Contract may be terminated from either side by giving one month notice or payment of notice pay in lieu thereof.

# II. <u>PROFILE</u>

Radio Operators will be responsible for the following:

1) To man the 4<sup>th</sup> floor Offshore communication Room from 0800 hrs to 2000 hours daily.

2) To collect position report from vessels and to send the compiled report (DPR-Daily Position Report) by e-mail to all SCI officers concerned.

3) To maintain contact details of senior officers on Board vessels and to send it by e-mail to all SCI's officers concerned.

4) To communicate the daily position report (DPR) of all offshore vessels with Navy and ODAG.

5) To collect information and to intimate the FP department/Offshore Department about the manpower requirement of Offshore vessels.

6) To maintain the radio watch on SSB and VHF from 0800 hours to 2000 hours daily.

7) To maintain continuous watch during emergency and during contingency.

8) To liaise with vessels and superintendents/FP department/Store department to meet vessel's requirement.

9) To communicate with ONGC, Port authority, Coast Guard and MRCC as and when required for Vessel's positioning and tracking.

10) To assist in filing/office work in Offshore Department/Ship Survey/Dock visit etc.

11) Any other jobs assigned for smooth operation of the vessels.

# III. SELECTION PROCESS

Interviews will be held in Mumbai.
