Reply: The recruitment is done as per SCI's recruitment policy and Government of India guidelines issued from time to time. The number of vacancies are based on the requirement and the attrition in the organization. The recruitment is at E2 i.e. at Assistant Manager level, and is made through Direct Recruitment on All India Basis by Open Competition method. In an open recruitment drive, selection is based on Written test, Group Discussions and Personal Interview.

6. Is there any concession (i.e. 5% concession in secured marks) in minimum educational qualification for reserved category (i.e. SC, ST, OBC & GEN).

Reply: Yes, there is relaxation of 5 % in the educational marks for SC/ST/PWD candidates.
