Response

SCI recruits officers as follows:

- a. Regular officers Officers are on SCI payroll and are entitled to wages as per INSA-MUI agreement.
- b. Regular officers opted for contractual wages These officers get all inclusive day rates as wages for each day of article period.
- c. Direct contract officers These officers get all inclusive day rates as wages for each day of article period.

All categories are governed as per INSA MUI agreement and SCI's Fleet Personnel Divisional Guidelines.

"It is agreed between MUI and INSA that an officer of permanent employment of the company, while in service takes up employment elsewhere, if proved, Company may take appropriate action, including dismissal of such errant officer without any terminal benefits being paid."

Unquote

In accordance above clause, Mr.Ankit Vyas services with SCI are terminated. After file closure and settlement of all dues/ recoveries as applicable, sea time letter will be issued.

6. If as per letter from DGM- FRPD dated 11 April 2019 employee 08582876 was under permanent employment, then why PF was not mentioned in the Article of Agreement.

Response

As per our record, PF has not been mentioned on Article of Agreement. Nevertheless, the PF during duly deposited for the period served as regular officer.
