We are in receipt of your RTI application dated 10.12.2018 received by the undersigned on 14.12.2018 seeking information under the Right to Information Act, 2005.

1. Is your Corporation aware of the Sexual Harassment of Women at Work Place (Prevention, Prohibition and Redressal) Act?

Reply: Yes, The Shipping Corporation of India Ltd. is aware of the 'The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013'.

2. Has your Corporation formed an Internal Grievances Committee and the Local Grievances Committee in compliance with this law? If yes, then what is the composition of the Internal Grievances Committee and the Local Grievances Committee?

Reply: Yes, an Internal Complaints Committee (ICC) to handle cases of Sexual Harassment at work place so constituted as per the 'The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013'.

The composition of the committee is as under:

One female employee of the organization at a senior level designated as the Chairperson of the committee, two employees of the organization as members of the committee and one member from the NGO "Pratham".

Informatively, as per the act, "Local Committee" is constituted by District Officer to receive complaints of sexual harassment from establishments where the Internal Committee has not been constituted due to having less than ten workers or if the complaint is against the employer himself.
