Sub: Application under the RTI Act 2005.

Further to our letter dated 10th September, 2019 furnishing replies to Q nos 4-8, kindly find our replies to your RTI question nos. 1-3.

1. SCI, apart from its contribution of Rs. 3.5 crores, had collected one time contribution of Rs. 7000/-, 5000/- and 4000/-, depending upon the grade, from its employees at the time of finalization of PRMS in 1994 giving effect from 01.01.1992. Please provide the total sum so received by SCI by way of one time contribution.

Reply: Information not available.

2. Please let me know whether the PRMS was extended to those who retired before 1992 by collecting one time contribution, as per the decision of the Board, and if your reply is YES then how many employees retired before 1992 were added to PRMS and the total amount collected from them.

Reply: Yes, the Post Retirement Medical Scheme (PRMS) was extended to those employees who retired before 1992 by collecting one time contribution, as per the decision of the Board. Approximately 110 employees who retired before 31.12.1992 were added to the PRMS. No other information is available.

3. When new PRMS was introduced from 01.01.1997 employees were asked to exercise option either to continue with the old scheme or to join the new scheme and employees who opted for new scheme were required to pay 50% of their last drawn basic pay at the time of retirement. This practice was discontinued in August 2011. In this regard please provide following information:

- i) Number of employees who opted for old scheme
- ii) Total employees who opted for new scheme year wise from 01.01.1997 till August 2011 (i.e the time when SCI stopped collecting 50% of basic from the employees) and amount collected from them year wise from January 1997 till August 2011.

Reply: (i) Approximately 571 employees opted for the old scheme.
