4.Number of employees retired from 01.01.1992 to 31.12.2006 who have submitted existence certificate during the financial year 2017-18 and 2018-19.

**Reply:** Number of employees retired from 01.01.1992 to 31.12.2006 who have submitted existence certificate during the financial year 2017-18 is 108 employees and in the financial year 2018-19 is 227 employees.

5. Number of employees retired from 01.01.2007 who have submitted existence certificate during the financial year 2017-18 and 2018-19.

**Reply:** Number of employees retired from 01.01.2007 who have submitted existence certificate during the financial year 2017-18 is 126 employees and in the financial year 2018-19 is 163 employees.

6. As per various circulars issued by DPE ending with OM No. W- 02/0046/2018-DPE (WC)-GL XXII/18 dated 27<sup>th</sup> September 2018 giving guidelines for creation of corpus only for providing medical benefits and any other emergency needs of those who retired before 01.01.2007, PSUs are required to contribute 1.5% of PBT for providing medical benefits and any other emergency needs of those who retired before 01.01.2007, PSUs are required to contribute 1.5% PBT for providing medical benefits and any other emergency needs of those employees who retired before 01.01.2007. 7. As per DPE/ Ministry instructions, a scheme is to be formulated for postretirement medical benefits for the employees who retired prior to 01.01.2007. Has SCI formulated such a scheme. If yes, what is the scheme.

**Reply:** Yes, there has been Post Retirement Medical Scheme for employees who have retired prior 01.01.2007. Post wage revision in 1997, a new PRMS scheme was launched with the approval of the Board on 9.10.2001.

Thus there were two schemes for post retirement medical benefits:

- For those retiring between 01.01.1992 and 31.12.1996 (old PRMS).
- For those retiring between 01.01.1997 and 31.12.2006 (new PRMS).

The benefits under 'old PRMS' and 'new PRMS' were as follows:
