I have resigned and relieved from services of the Corporation and received the final relieving letter. Kindly furnish the following information:

3. Procedure to transfer the Pension Fund Amount to my present employer.

5. Copy of Transfer Form of Pension Fund amount.

Reply for query no. 2, 3, 4, and 5:

In accordance with the DPE OM No. No.2 (70)/08-DPE(WC)-GL-XVI/08 dated 26.11.2008, Pension can be extended to those executives, who superannuate from the CPSE and have put in a minimum of 15 years of service in the CPSE, prior to Superannuation.

You joined SCI on 24.08.2015 and resigned from the services of the Corporation on 20.05.2016. Hence, in accordance with DPE guidelines considering that you were not having minimum requirement of 15 years of service, pension is not payable.

In view of above, we hope you will be satisfied with the information. However, if you desire, you may prefer an Appeal before the First Appellate Authority i.e. Director (P&A) of the Corporation, "Shipping House", 245, Madame Cama Road, Mumbai - 400 021 within 30 days from the receipt of the decision.
