“ONGC had awarded contract for operation, maintenance and management of their vessels namely, Samudra Sevak, Samudra Prabha and Samudra Sarvekshak in the year 2003.”

1. *Letter of Intent given by ONGC to SCI for above mentioned vessels.*

Reply: Information is not available with SCI.

2. *Copy of Contract/ MOU signed with ONGC by SCI for above mentioned three vessels.*

Reply: Apropos copy of Contract/MOU, it invariably contains the commercial deployment of the vessel, remuneration & confidential clauses, the disclosure is exempted under section 8(1)(d) of the RTI Act 2005.

3. *What was the duration of contract for above mentioned ONGC vessels.*

Reply: Contracts were awarded for duration in the range of 3 months to 3 years.

4. *Did ONGC charged any downtime/ penalty from SCI during the contract period for above mentioned vessels.*

Reply: Downtime/penalty charged as applicable.

5. *How much of total amount during the contract period was deducted by ONGC towards downtime for the above mentioned three vessels.*

Reply: Total amount of deductions for each vessel is given as under:

- Samudra Sevak – Rs.46,36,673
- Samudra Prabha – Rs.1,05,12,602
- Samudra Sarvekshak – Rs.1,81,44,646
