We are in receipt of your RTI application dated 28.10.2019 received by the undersigned seeking information under the Right to Information Act, 2005.

Kindly find our replies;

1. Who Conducts auction of vehicles which has been condemned or are certified not fit for use, used by Shipping Corporation of India, its divisions, branch offices and other departments.

ANS:- SCI does not conduct auction of vehicles. Tender for sale of car on "As is where is basis" is put up on SCI website and Govt. CPPP Portal.

2. What is the procedure adopted by Shipping Corporation of India, its divisions, branch offices and other departments to conduct auction of condemned vehicles/vehicles which are certified not fit for use.

ANS:- :- SCI does not conduct auction of vehicles as mentioned above.

3. Is there any rules, acts, regulations or governmental orders governing the mode and method in conducting auction of condemned vehicles/ vehicles which are certified not fit for use by Shipping Corporation of India, its divisions, branch offices and other departments.

ANS:- :- We do not conduct auction of vehicles. So it is not applicable even if guidelines exist.

4. What is the total fee that I need to pay in order to get a copy of rules, acts, regulations or governmental orders governing the mode and method in conducting auction of condemned vehicles/ vehicles which are certified not fit for use by Shipping Corporation of India, its divisions, branch offices and other departments?

ANS:- :- SCI is not aware of any fee payable to get copy of rules, acts etc. .

5. What are the criteria for determining maximum life of a vehicle used by Shipping Corporation of India, its divisions, branch offices and other department.

ANS:- Maximum life of vehicle/vehicles are decided on the **performance** of the vehicle. As per **Government rules**, generally vehicles are required to re-register with RTO after 15 years. So vehicles are sold after 15 years. Sometimes due to extensive use of vehicle and **maintenance cost** of old vehicles, life of the vehicle can be less than 15 Years.

6. What is maximum time period for which a vehicle is used by Shipping Corporation of India, its divisions, branch offices and other department.

ANS:- Maximum time period of 15 Years.

7. Can a person who is residing in another state participate in auction conducted by Shipping Corporation of India, its divisions, branch offices and other departments, for sale of vehicles which are condemned or which are not fit for use

ANS:- :- SCI does not conduct auction of vehicles. But any resident of India can participate in Sale of Old Vehicle Tender floated by SCI on Website and CPPP website.

8. In which mode does Shipping Corporation of India, its divisions, branch offices and other departments advertise to public when condemned vehicles are being auctioned.

ANS:- SCI does not conduct auction of vehicles. Open Tender is floated for Sale of Old Vehicles after due Management Approval. Tender is uploaded in SCI website and CPPP Govt. Website as per current tender guidelines.

In view of above, we hope you will be satisfied with the information. However, if you desire, you may prefer an Appeal before the First Appellate Authority i.e. Director (P&A) of the Corporation, "Shipping House", 245, Madame Cama Road, Mumbai - 400 021 within 30 days from the receipt of the decision.
