**Reply:** The corpus as per audited balance sheets of Mar. 2007 and Mar. 2006 are Rs. 6.96 crores and Rs. 7.15 crores respectively

5 Number of employees retired prior to 01.01.2007 who have exhausted their entitlement under PRMS and also who have balance less than 10 % of their entitlement to their credit as on date.

**Reply:** As on June 2019, thirty three (33) retired employees have exhausted their entitlement and thirty eight (38) employees have balance of less than 10 % of their entitlement to their credit.
