Information regarding ship service running under shipping corporation of India from Chennai to portblair, the category wise fare list for seats, journey timing and distance in nautical miles or kms.

Tickets fare for children below 5 years.

**Reply** There are 3 Ships of 1200 passengers capacity each running between Main land on the East Coast of India (Kolkata, Vizag and Chennai) and Port Blair. These ships are owned by Directorate of Shipping Services (DSS), Andaman & Nicobar Administration and managed by The Shipping Corporation of India Limited. The tickets are booked by Directorate of Shipping Services, A&N Administration. The Distance from Chennai to Port Blair is 773 NM and transit time is approximately 3 days.
