The Company has received email(s) dated 22.05.2024 from BSE Limited and National Stock Exchange of India Limited levying fine of Rs. 5,36,900/- each (Rs. 4,55,000 each plus 18% GST) for non- compliance with Regulation 17(1) of SEBI (LODR) Regulations, 2015 w.r.t Composition of Board of Directors.

The action does not have significant impact on financial, operation or other activities of the Company, quantifiable in monetary terms to the extent possible.
